1. AUTHORITY

The M-Electrolyte 25th South East Asian Junior & Cadet Table Tennis Championships will be organized by the Table Tennis Association of Thailand (TTAT) under the authority granted by the South East Asian Table Tennis Association (SEATTA).

The host country can enter twice the number for all but team events.

5. AGE LIMIT

5.1. Junior: Born on or after 1 January 2001

5.2. Cadet: Born on or after 1 January 2004

6. RULES

The latest laws of table tennis & regulations for international competitions in the ITTF Handbook shall be adopted in the Championships.

7. DRAW

The draws will be made under the supervision of SEATTA Technical Committee. The draw for Team Events will take place on **3rd June 2019 at 16:00** in the hotel and the draw for Individual Events will be announced later. Representatives from the participating Associations are welcome to attend the draw.

10. SYSTEM OF PLAY

10.1. Junior Team Events

The team competition will be conducted in two (2) stages

10.1.1. Stage 1

Teams will be divided into two (2) groups to play a Round Robin System to determine the group winners

10.1.2. Stage 2

The top two (2) teams from each group will play a Knockout System to determine the positions of 1st, 2nd, 3rd and 4th

Order of Play A vs. X, B vs. Y, C vs. Z, A vs. Y, B vs. X

All team matches shall be best of five (5) games

If the number of participating teams is less than 6, the teams will play a Round Robin System to determine the winners.

10.2. **Cadet Team Events**

The team competition will be conducted in two (2) stages

10.2.1. Stage 1

The teams will be divided into two (2) groups to play a Round Robin System to determine the group winners.

10.2.2. Stage 2

Top two (2) teams from each group will play a Knockout System to determine the winners. There will be no playoff match for 3rd/ 4th position.

Order of Play A vs. X, B vs. Y, Double, A vs. Y, B vs. X

All team matches shall be best of five (5) games

If the number of participating teams is less than 6, the teams will play a Round Robin System to decide the winners.

10.3. **Singles Events**

The Singles competition will be conducted in two (2) stages.

10.3.1. Stage 1

Players will be divided into groups depending on the number of entries to play a Round Robin System to determine the group winners.

10.3.2. Stage 2

Group winner/winners shall play a Knockout System to determine the winners.

The matches shall be best of five (5) games, except Semi-Finals and Finals matches shall be best of seven (7) games.

10.4. **Doubles Events**

All double events to be played in a Knockout System to determine the winners.

All double matches shall be best of five (5) games.

One player is entitled to participate in only one age group for each event.

11. **SEEDING**

10.1. Seeding for team and individual events shall be based on the results of the 24th SEA JC TTC 2018.

10.2. In the event teams or players not included in the result list, the latest ITTF ranking shall be taken into consideration.

10.3. The seeding list shall be furnished by the SEATTA Technical Committee Chairman who shall advise the organizing Committee on the preparation of the draw.

The Jury shall consist of the following:-

- 14.1. A Chairman appointed by the SEATTA Technical Committee
- 14.2. One representative from the Organizing Committee
- 14.3. Three (3) Team Managers whose teams are not involved in the dispute
- 14.4. The Referee who shall have the right to speak but not to vote

15. ENTRIES AND CLOSING DATES

Entry form should reach both Organizing Committee and SEATTA Secretariat for the 25th SEA Junior & Cadet Table Tennis Championships by email before the deadlines as follows.

In addition, upon request, each association may need to send the accreditation photos (jpg file) for their members who will participate in the event to the organizing committee for the preparation of the accreditation.

- No additional entry is allowed after the final entry deadline, yet player changes or withdrawals could be accepted for any registered players. These modifications shall be received by the Organizing Committee and SEATTA secretariat at the latest on **24th May 2019** at **17:00** local time.

16. HOSPITALITIES

The Organizing Committee shall provide free hospitality from the **dinner on Monday 3rd June 2019**, to the **breakfast on Monday 10th July 2019**, including board and lodging to the following:

16.1. 3 junior boys, 3 junior girls, 1 Cadet Boy, 1 Cadet Girl and 1 Official

16.2. Same hospitality shall be provided for extra participants/ officials at a cost of **USD120** per person per day for twin sharing room or **USD160** per person per day for single room.

16.3. The organizing committee will provide the reasonable airfare (Economy) for the Technical Delegate and one foreign Deputy Referee.

16.4. Each participating country may nominate ONE (1) International Umpire and it must be indicated in the Umpire Nomination Form (Annex 2). The umpire or his/her Association will be responsible for his/her own airfare to Naga City airport. Please note that **not every** nominated umpire will be selected for the competition.

16.5. The Organizing Committee will provide free hospitality and daily allowance to all foreign International Technical Officials (ITOs) in accordance to ITTF regulations.

16.6. Cancelling entry and accommodation: For those Associations who cancel their entry and accommodation after **24th May 2019**, the Organizing Committee will charge **US\$100** per person. Full payment is to be borne by the association.

16.7. All meals will be served with no pork and lard.

20. LIABILITY

20.1 By entering the Championships, participants agree to abide by all SEATTA rules and by the rules and regulations of the Organizing Committee. All entered associations, pairs and individual players agree to be under the auspices of the SEATTA and its agents in all matters concerning television coverage, video, internet web casting, motion picture coverage, and photographic coverage of any kind. Participants release all rights, or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage; and hence accept such coverage during the Championships. A participant's refusal of the above listed coverage may be subject to suspension or dismissal from the competition. Any participant, when called upon, must appear promptly to press conferences or medal presentations and follow the procedures set by the SEATTA and the Organizing Committee.

20.2 By entering the Championships, each Association must ensure that all delegation members confirm that they know that their personal data will be shared with the Organizers and SEATTA who, in turn, undertake not to share it with any unauthorized person in any way.

20.3 By entering the Championships, all delegation members undertake to abide by the ITTF's anti-doping rules.

20.4 By entering the Championships, each association must ensure that all delegation members have travel insurance for the duration of the Championships.

21. MISCELLANEOUS

Racket Testing shall be conducted in this competition, under ITTF Regulations.
